# **Great Eastern Alice Saves Wonderland Contest – Terms and Conditions**

## Eligibility

By participating in this Contest, participants are taken to have read, understood and agreed to be bound by these Terms and Conditions, and accept that all decisions by the Organiser are final and binding. The Organiser reserves the right at its sole and absolute discretion to change, amend, add or delete any of these Terms and Conditions at any time, which may be communicated through modes of communication deemed suitable by the Organiser, and without prior notice to the participants and the participants agree to be bound by such changes.
- 27. Failure or delay by the Organiser to enforce any provision of these Terms and Conditions shall not constitute to a waiver of that provision.
- 28. These terms and conditions shall be governed by and construed in accordance with the laws of Malaysia.
