Colour Me Up! 2024

Contest Terms & Conditions

- 1. The Colour Me Up! 2024 Colouring Contest ("Contest") is organised by Great Eastern Life Assurance (Malaysia) Berhad (93745-A) ("Organiser") and is only open to all Malaysian nationals aged between seven (7) to twelve (12) years ("Contestant(s)") and to all national primary schools nationwide ("School(s)"), except all children of employees (permanent, temporary or on contract basis) of the Organiser.
- This Contest commences from 9 September 2024 to 15 November 2024 ("Contest Period").
 The Organiser reserves the absolute right to shorten or extend the Contest Period if deemed necessary without prior notice. Entries received after the Contest Period will not be entertained.
- The Contest mechanics are as follows:
 - 3.1. Contestant(s) are to draw and colour/complete the picture in the Contest entry form by using colouring tools.
 - 3.2. Contestant(s) are to complete the slogan, "GREAT is.." in not more than twenty (20) words.
 - 3.3. Each Contestant may submit more than one (1) entry. However, each Contestant is only entitled to one (1) prize ("Prize") per person.
 - 3.4. Judging criteria
 - 3.4.1. Contestant(s)

Entries for each Contestant will be judged on the basis of creativity on colouring, drawing and slogan completion.

3.4.2. School(s)

School winners will be determined based on the highest participation ratio, i.e. total completed participation divided by total number of students in the School. Should the participation ratio be equal for 2 or more Schools, the date of receipt will be used as the deciding factor (the earlier submission wins).

- 3.5. All Contest entry forms must be completed in full and signed by a parent or legal guardian. The Organiser reserves the right to disqualify entries with invalid or incomplete details.

- 9. Contestant(s) must complete the colouring and slogan portions of the Contest entry form by themselves without the assistance from any third party(ies).
- 10. The Organiser reserves the right to disqualify entries (at any stage of the Contest) that do not meet the Contest mechanics and/or have invalid or incomplete details.
